EXECUTIVE ORDER

No.eCF-329382/2289

Subject: Exemption from passing departmental examination for confirmation of service of Assam Police Service officers

Rule 17 of the Assam Police Service Rules, 1966 (as amended), prescribes the criteria to be fulfilled for confirmation of service in the Assam Police Service. It has, however, been observed that members of the Assam Police Service, on several occasions, submit applications seeking exemption from passing the prescribed departmental examinations for confirmation of their service.

After careful examination of all aspects of the matter, the Government has decided that the following principles shall be observed in respect of departmental examinations:

1. It should be the endeavor of all members of the Assam Police Service to pass the departmental examinations within the stipulated time after joining the service.
2. No proposal for exemption from passing departmental examinations will be entertained unless the officer has appeared in a particular paper at least three (03) times.
3. Exemption from passing departmental examinations will be considered only in exceptional circumstances and not as a matter of routine.
