Branch office, Zone-I complex.

The condemned tyres & tubes, batteries and condemned motor parts (scrap) for sale will be available for inspection on any working day, between 10 AM to 4 PM, before the auction date. The intending bidders will have to deposit an amount of **Rs. 1,000.00 (Rupees One Thousand) only as security in the form of Bank Draft** before the auction.
