AUCTION NOTICE

It is for General Information that the following condemned motor vehicles of this office will be sold in Public Auction in SEALED TENDER basis at the M.T. Branch, premises A.P. Hqrs., Ulubari on **11/07/2019**.

Thereby sealed Tender affixing court fee of Rs.8.25 (Rupees Eight, paisa Twenty Five) only are invited from the intending tenderers/ parties. The Tenders will be received by the undersigned in this office **up to 02.00 PM** and will be opened on the same day **@ 03.30 PM** as per the terms and condition laid down below:-

1. Vehicles offered for sale will be available for inspection on any working day in between 10 AM to 4 PM before the auction date. The intending parties may contact the **Motor Transport Inspector of Assam Police Headquarters, Ulubari, Guwahati**.
2. The intending bidders will have to deposit an amount of **Rs.10,000/- (Rupees Ten Thousand) only as security in form of Bank Draft**. And the deposit in case of unsuccessful tenderers will be returned, and in case of successful tenderers, the security will be refunded after lifting of the vehicles.
3. The successful bidders will have to lift the vehicle from the premises of the A.P.Hqrs, Ulubari within 3 (Three) days from the date of disposal after depositing the entire value of the sold vehicle in advance to the undersigned on the same day before lifting the condemned vehicles at his own cost and risk else his security will be forfeited to the Govt.
