Sealed tenders affixing court fee stamp of Rs. 8.25 (Rupees eight and paisa twenty five) only are invited from the Registered Industries / Firms by the undersigned to dispose off unserviceable dismantled sections with accessories of **"80 feet Self Supporting Tower"** of APRO having weight of 4700 kg approximately.

Tenders will be received up to **1300 hr on 30/06/2023** in the office of the Spl. Director General of Police (Communication), Ulubari, Guwahati-7 and will be opened on the same day at **1500 hrs**. The tender must be sealed and superscribed as **"BID FOR UNSERVICEABLE 80 FEET SELF SUPPORTING TOWER OF APRO"**. One authorized representative of bidder will be allowed to present at the time of opening the tenders. Successful bidder will be intimated after finalization of the tender.

**Inspection at Site: Inspection will be allowed if Tender document is in hand, between 12 AM to 3 PM from 12 -06-2023 to 28 -06-2023.**

The Bidder must submit the following along with the quotation.

1. Copy of Firm Registration, duly attested.
2. Copy of Sales Tax / GST registration certificate, duly attested.
3. Copy of PAN card in the name of owner/name of the firm, duly attested.
4. Up to date Copy of Trade license, duly attested.

**Quotations without the above documents will not be accepted for consideration.**

The bidders must invariably be deposited the **EARNEST MONEY of Rs 12,000.00 (Rupees Twelve thousand) only** in the form of NSC / KVP / Fixed Deposit in favour of **Director of Police (Commn) Assam, payable at Guwahati.**

The stores will be auctioned to the successful bidder who offered highest rate above the minimum price fixed by the authority.

The rates should be quoted both in figures & words distinctly. Any alteration, correction, modification of the rates over the original shall not be accepted.



The successful bidder will have to deposit the **TOTAL CONTRACT VALUE** in the form of Bank Draft in favour of **Director of Police (Commn) Assam**, within 2(two) days from the date of finalization of the bid. In case the successful bidder fails to deposit Contract Value in time, the **EARNEST MONEY** so deposited will be forfeited.

The successful bidder shall also be liable to lift the store from APRO HQ, Ulubari, Guwahati-7 within **24 (Twenty four) hours** after depositing the full amount.

In case the successful bidder fails to lift the store within the stipulated time, the **EARNEST MONEY** and the **CONTRACT VALUE** so deposited will be forfeited.
