2. The Tender should be sealed and duly subscribed as "Tender for supply of motor spare parts & repairing works for the financial year 2024-2025".
3. The Tenderer should quote their rates of Genuine/Original Spare Parts only and Taxes should be shown separately. The rate should be clearly written in figures and there should not be over writing /erasing of rates. The quoted rates will not be accepted in hand writing form instead must be furnished and prepared in pure Excel sheet format in both hard and soft (CD) copy. The soft copy should contain one Excel sheet (without putting any formula) and a pdf format of the same.
4. The tenderers or their representatives may remain present at the time of opening the tenders.
5. The tenderers should submit the following with their tenders without which the tenders will be liable for rejection.
6. Documents to be submitted: Up to date -
 - a. A.P.(HQ) Registration Certificate.
 - b. G.S.T. Registration Certificate.
 - c. Trade License (for supply of spare parts).
 - d. Labour License (for work shop).
 - e. Firm Registration (As applicable).
 - f. I.T. return for last 3 (three) years.
 - g. G.S.T. Return for the last financial year.
 - h. Pan Card.
- (7) Earnest money of Rs. 15,000/- (Rupees Twenty five thousand) only for spare parts supply and Rs. 10,000/- (Rupees Fifteen thousand) only for repairing works in the form of bank draft / Deposit of call receipt duly pledged in favour of undersigned.
- (8) The rate once approved will remain valid for one year or till the next approved list issued, which ever is earlier.
- (9) The approved firms will have to execute a deed of contract with the undersigned.
