TERMS AND CONDITION

1. The tender must be sealed and the envelope containing the tender should be super scribed as "TENDER FOR SUPPLY OF DOG DIEATRY AND OTHER RELATED ARTICLES" for the district Police Dog Unit, Jorhat for the financial year 2024-25.
2. The intending tenderer / supplier should have own registered firm with GST Registration No and up to date GST return.
3. No provision to receive any documents / papers after submission of the tender.
4. Each tender must be affix with Court fee stamp of Rs. 8.25 (Rupees Eight and Twenty Five only), otherwise the tender will be rejected.

5. The rate to quote on tender should be written in both of number and words legibly. Any alteration / correction / erases etc. should be authenticated by the tenderer himself before submission of the tender.
6. Each tender must be carrying attested copies of up to date documents like trade license etc. otherwise, the tender will be cancelled.
7. Attested copies of firm registration certificate with up to date renewal must be furnish alongwith the tender. The rate once accepted will remain valid up to further tender. (Except under extra ordinary situation)
8. The successful tenderer / supplier will have to supply as and when indent is placed for within the period as specified therein without fail. No extension of time without any valid reason what so ever will be granted.
9. The rate quoted shall be inclusive of all taxes, if any.
10. The authority is not bound to accept for not to accept the lowest tender / supplier or to assign any reason for accepting any tender / supplier thereof. He also reserves the right to cancel the contract before the expiry of the terms of the contract for any reason viz. supply of inferior quality or falling to supply the said articles in time.
11. If the last date of the receiving tender fall on any Govt. Holiday / Bandh etc. The subsequent working day will be treated as the last date of receiving tenders.
12. Earnest money @ 1000/- pledged in favour of the undersigned should be accompanied along with the tender in the shape of Bank Draft / Banker's cheque etc.
13. The earnest money of unsuccessful tenderer will be returned after finalization of the tender. However, the earnest money of successful tenderer will be retained as security deposit for due performance of supply.
14. The article should be fresh and of standard quality and the successful tenderer must be in a position to replace immediately if the articles are not found proper.
15. The tenderer will be required to produce the samples as when called for. The authority reserves the right to reject or except all the tenders without assigning any reason thereof. The authority is not bound to accept the lowest rate quoted by the tenderer.
16. All the selected firms / suppliers will execute a deed of agreement immediately with the undersigned before supply is made and furnish his / her PAN Card issued by the Income Tax Department.
