Notice inviting Tender for supply of Spare Motor Parts including job works for Hailakandi District Police during the financial year 2023-24 was issued vide this office Memo No. HKD/MT/Spare parts/2023/47, dtd.12.04.2023 and extension Signal No. HKD/MT/2023/48, dtd.25.04.2023, the date of tender was rescheduled on 16.05.2023 but no bidder has submitted quotation for the tender.

Hence Notice re-inviting sealed tenders affixing court fee stamp of Rs. 8.25p only are hereby invited from the intending Proprietors registered under Assam Police Headquarters, Guwahati for supply of Spare Motor Parts including job works for Hailakandi District Police during the financial year 2023-2024. The tenders will be received in the office of the undersigned up to 2 P.M. of 30.06.2023 and will be opened on the same day at 3 P.M. or on the subsequent working day if it falls on a Govt. holyday in presence of intending tenderers or their authorised representatives. The intending tenderers may collect list of tendered spare motor parts and the list various types of vehicles of Hailakandi District Police from the MT Branch, Police Reserve, Hailakandi from 9-30 A.M. to 5 P.M. on any office working day submitting petition along with supporting documents in respect of his firm.

TERMS & CONDITIONS

1. Tender without court fee stamp will not be accepted.
2. The tenderers will have to submit the following documents along with the tender, failing which no tender will be accepted.
 - a) Attested copy of firm registration certificate.
 - b) Attested copy of GST Registration Certificate.
 - c) Attested copy of Income-Tax clearance certificate.
 - d) Attested copy of PAN card.
 - e) Attested copy of Trade Licence.
3. Tenderers must deposit Rs. 5,000.00 (Rupees five thousand) only as earnest money in the form of call deposit pledged in favour of the undersigned.
4. The earnest money of un-successful Tenderers will be released after acceptance of rates and earnest money of the successful Tenderers will be retained as security money. The security money will be forfeited to the Govt. in case the selected supplier/ firm fails to supply as per indent.
5. The rates must be neatly typed with clear indication of the unit (i.e. Part No. / Make etc) with quantum of the contents etc for which the same stands for.
6. Most importantly quoted rate will not be accepted in Hand Written form, instead must be furnished and prepared in pure Excel format in both hard copy and soft copy under authentication of the tenderers.
7. The successful tenderer (s) will have to sign agreement with the undersigned.
8. The selected tenderer (s) will be required to deliver the articles in the office of the undersigned on receipt of the proper indent immediately. No delivery charge will be paid to the supplier/ firm by the undersigned for delivery of the articles in this office.

9. The selected tenderer will be bound to supply the articles at his quoted rates throughout the financial year and no representation whatsoever will be entertained for enhancement of rate subsequently.
10. Only the best quality articles/ materials will be accepted. The approved supplier will be required to take back the rejected articles at his own cost.
11. Payment of the bills will be made depending upon the availability of fund. No extra charges will be entertained if the payment is delayed due to non-availability of fund.
12. Earnest money of the successful tenderer who will refuse to supply after final selection by the undersigned will be forfeited to the Govt.
13. The undersigned is not bound to accept the lowest rate and reserves the right to reject any or all the tenders without assigning any reason thereof.
14. The procurement will be done as per Assam Public Procurement Rules 2020.
