NOTICE INVITING RATE TENDER

Sealed tender affixing Court Fee Stamp of Rs. 8.25 (Rupees eight and twenty five paise) only are hereby invited from the intending registered Contractor/Supplier for supply of (1) Office/Stationery articles, (2) Computer & Xerox articles, (3) Electrical articles, (4) Food & Refreshment items and (5) Miscellaneous articles (list enclosed) for the financial year 2023-24 in the Office of the Superintendent of Railway Police, Assam, Pandu, Guwahati-12. The tenders will be received by the undersigned on or before 06.03.2023 up to 2 PM and will be opened on the same day at 4 PM in presence of the tenderers/bidders or their authorized representatives who may like to present. If the last date of receiving tenders falls on any holiday/band etc. the subsequent working day will be treated as the last date receiving the tenders. (tender paper/list of articles will available for collection from this office during office hours).

Terms and Conditions:-

- (1) The tenders must be sealed cover and should be superscribed as "<u>Tender for Supply of Office & Stationery/Computer & Xerox/Electrical/Food & Refreshment items/ Miscellaneous articles for the financial year 2023-24 in the Office of the Superintendent of Railway Police, Assam, Pandu, Guwahati-12" and to be put up in the "<u>Tender Box</u>" placed in front of Office chamber of the Superintendent of Railway Police, Assam, Pandu, Guwahati-12.</u>
- (2) The rate of the items should be mentioned clearly both in figure and words against each item (i.e. no./each/dozen/kg./box/pkt./unit etc.), quality/brand of the items should be mentioned against each item. Any over writing, erasing etc. of the rate quoted will be rejected. Any alteration/correction of the rates should be duly signed by the tenderer/bidder.
- (3) GST Registration is mandatory. A copy of GST Registration must be accompanied with the documents.
 - (4) The rates quoted against each item should be exclusive of GST.
- (5) Each and every tenderer/bidder must furnish earnest money of Rs. 5,000/(Rupees five thousand) only in the form of National Saving Certificate/Kishan Bikash
 Patra/Demand Draft/Bank FDR/Irrevocable bank Guarantee pledged in favour of the
 Superintendent of Railway Police, Assam, Pandu, Guwahati-12 along with the tender. Tender
 without requisite earnest money in the manner indicated above will not be considered. No
 Cheque/Cash will be accepted.
- (6) The earnest money of the unsuccessful tenderers/bidders will be returned immediately after finalization of tenders. However, the earnest money of successful tenderers/bidders will be retained as security deposit for due performances of supplies, if desired by the party concerned.
- (7) The successful tenederer/bidder shall have to furnish Rs. 5,000/- (Rupees five thousand) only as security deposit and shall furnish in the manner as in "Clause-5".

- (8) The tenderers/bidders must submit photocopies of the following documents along with the tender without which the tender will be liable for rejection.
 - (i) Permanent Account Number (PAN) issued by the Income Tax Department,
 - (ii) Up to date Municipal/Gaon Panchayat Trade License, (iii) Up-to-date GST return, (iv) Up-to-date Income Tax return, (iv) Certificate of GST/Income Tax Exemption from the competent authority, if any.
- (9) The rates quoted once can not be altered/withdrawn after submission of the tender and will hold for the financial years i.e. 2023-24. Any representation/appeal for enhancement of the rates on ground of rise of market price or any other reason whatsoever will not be entertained.
- (10) The selected tenderers/bidders shall have to sign the contract agreement with the undersigned on receipt of information from this end; failing of which the contract shall be liable to be cancelled and earnest money will be forfeited to the Govt. without any further notice to the tenderer/bidders.
- (11) The selected tenderers/bidders will have to supply the articles as and when indented. The articles supplied must be best quality or genuine make and must conform to the specification of brand as quoted.
- (12) If any article is found to be of inferior quality the same will be rejected out right and will be replaced at the risk and responsibility of the tenderer/bidders. The tenderer/bidders will be required to produced samples as and when call for.
- (13) In the event of selected/successful tenderers/bidders failing of to supply the indicated items completely within 7(seven) days from the date of receipt of supply order, the contract shall be liable to be cancelled without any further notice.
- (14) The undersigned reserve the right to reject any or all tenders without assigning any reason thereof. The lowest rate may not be compulsorily accepted and decision of the undersigned in this matter will be final and binding on the tenderers/bidders.
- (15) The tenderers/bidders are liable to submit departmental registration under Assam Police H.Q. (Group "A" Procurement of Good & Services etc.).
- (16) The entire document submitted along with the tender will have to be self attested.

The tenderer/bidders that do not fulfill the above conditions will not be entertained. The approved firm/supplier will have to execute a deed of agreement immediately with the undersigned before supply of articles.
