The tender should be submitted an earnest money of Rs. 1000.00(Rupees one thousand) only and the successful tenderer should deposit an amount of Rs.10,000/- (ten thousand) only as security money in Call Deposit receipt of postal saving account of NSC/KVP/Bank draft pledged in favour of Superintendent of Police Cachar, Silchar without which no tender will be considered.

The tenderer should submit certificate copies of the firms registration documents and copies of PAN card of firm along with the tender.

The tender should be written in ink or type and any correction /alternation should be initialed. The rates should be comparable to the prevailing market rates and should include all taxes and other charges for supply to Superintendent of Police.
