



Terms and Conditions:


1. The tenderers must furnish earnest money of Rs. 10,000.00 (Rupees ten thousand) only in the form of Bank draft duly pledged to the undersigned. The security money will be forfeited to the Govt. in case the selected supplier fails to supply as per indent.
2. All tenderer must submit firm registration certificate or Trade license or factory license issued by competent authority, up to date Income tax return for last 2 years i.e. 2017-18 and 2018-19., GST No. and PAN no. along with the quotation and failing which the quotation will be treated as invalid.
3. Tenderer should submit an Affidavit regarding their Non-blacklisting or debarment by any Govt. / Semi Govt. Orgns. on previous occasion for indulging in illegal, unethical, corrupt etc. practices.
4. Total requirement along with list of items for procurement of uniform items is enclosed herewith as Annexure- I".
5. The tenderer must submit one Readymade sample of each items quoted duly sealed mentioning the Serial number of Item, Name of Item, Name of Bidder.
6. The selected tenderer will be required to deliver the articles in the office of the undersigned on receipt of the proper indent. No delivery charge will be paid to the firm by the undersigned for delivery of the articles in the office.
7. The selected tenderer will be bound to supply the articles of approved brand and samples at his quoted rate throughout the year and no representations what so ever will be entertained on the ground of enhancement of rate subsequently.
8. The undersigned is not bound to accept the lowest rate and reserves the right to reject any or all the tender rates without assigning any reason thereof.
9. Different tenderers may be selected for different items of articles for which no compliant will be entertained.
